### Invitation for Bids

1. Gaidahwa Rural Municipality, Rupandehi has allocated funds towards the cost for *Procurement of Supply and Delivery of General Medicine and Surgical Goods* and intends to apply part of the funds to cover eligible payments under the Contract for upgrading of roads under national competitive bidding (NCB).

2. Gaidahwa Rural Municipality, Rupandehi invites **only electronic bids** from eligible bidders for the *Procurement of Supply and Delivery of General Medicine and Surgical Goods* of the contract mentioned in table below:

4. Bidder must submit their bid electronically through e-submission from PPMO's e-GP system <http://www.bolpatra.gov.np/egp>.

5. Bidder shall be required to deposit the cost of bidding document (as specified in the table above) in the Employer's Rajaswa (revenue) account as specified below and scanned copy (PDF format) of the Bank deposit voucher shall also be submitted along with the electronic submission of the bid files.

6. Pre-bid meeting will be held in Gaidahwa Rural Municipality, Rupandehi Nepal, at **11.00 hrs** on **12<sup>th</sup> Kartik 2080 (29<sup>th</sup> Oct 2023)**.

7. Electronic bids must be submitted to the Gaidahwa Rural Municipality, Rupandehi by electronically through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) **on or before 12:00 hrs** on **21<sup>st</sup> Kartik 2080 (7<sup>th</sup> Nov 2023)**. Bids received after this deadline will be rejected.

8. All bids shall be accompanied by a Bid Security for the amount as specified in the table. Bidders are required to submit a separate bid security for each contract for which they submit bids. The bid security guarantee issued only by the commercial bank approved by Nepal Rastra Bank shall be accepted by the Employer. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format, which shall be valid for 30 days beyond the validity period of the bid.

9. The bids will be opened electronically at **13:00 hours** on **21<sup>st</sup> Kartik 2080 (7<sup>th</sup> Nov 2023)** in the presence of the bidders representatives who choose to attend at Gaidahwa Rural Municipality, Rupandehi

10. If the last date of pre-bid meeting, purchasing and /or submission falls on a government holiday, then the same time on next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

11. Gaidahwa Rural Municipality, Rupandehi, Nepal reserves right to accept or reject any or all bids or annul the bidding process and reject all bids without assigning any reason, whatsoever.

Addendum (if any), Information on Pre-bid meeting, Letter of Intent, Letter of Acceptance or any other documentation/notification pertaining to this procurement notice and that must be disclosed to the bidders as per prevailing rules and regulations will be uploaded in E-procurement section of PPMO's web Site <http://www.bolpatra.gov.np/egp>. and also e-mailed to the bidders.
