Invitation for Bids for the Construction of 15 Bed Primary Hospital

Government of Nepal and Gaidahwa Rural Municipality *has allocated funds* towards the cost of **Construction of 15 Bed Primary Hospital** of Gaidahwa Rural Municipality and intends to apply part of the funds to cover eligible payments under the Contract for Construction of 15 Bed Primary Hospital, Contract ID: **09/GRM/CON/NCB/2079/080** Bidding is open to all eligible as per Section V of bidding document.

1. **Gaidahwa Rural Municipality**, invites electronic bids from eligible bidders for the construction of 15 Bed Primary Hospital Building, Building of Gaidahwa Rural Municipality under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs 110000000**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidder to submit their bid electronically must purchase bidding document within office hour of **2079/011/22 B.S.** and can download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document (**NRs.10000**) in the Project's Rajaswa (revenue) account as specified below.

5. Pre-bid meeting shall be held at Gaidahwa **Rural Municipality** at **12:00hrs. on 2079/12/12B.S. (2023/03/26A.D)**.
6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00hrs. on 2079/12/22 B.S. (2023/04/05A.D)**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hrs on 2079/12/22B.S. (2023/04/05A.D)** at the **Gaidahwa Rural Municipality** Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Rs.5000000** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The employer reserves the right to accept or reject, wholly or partly any or all the bids with out assigning any reason whatsoever.
