1. **Gaidahawa Rural Municipality invites** sealed bids or electronic bids from eligible bidders for the **construction of various ward office building** under National Competitive Bidding-Single envelop bidding procedures.

A complete set of Bidding Documents may be purchased from the office **Gaidahawa Rural Municipality, Office of Rural Municipal Executive, Rupandehi, Province No.- 5, Nepal** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **NRs. 3000.00** till **20th June 2018 on or before 12:00 hour.**

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. Sealed or electronic bids must be submitted to the office **Gaidahawa Rural Municipality, Office of Rural Municipal Executive, Rupandehi, Province No.- 5, Nepal** by hand/courier or through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hours** on 20th June 2018. Bids received after this deadline will be rejected.
5. Pre-bid meeting shall be held at **Gaidahawa Rural Municipality, Rupandehi** at 2:00 PM on 10th June 2018.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 hours** on 20th June 2018 at the office **Gaidahawa Rural Municipality, Office of Rural Municipal Executive, Rupandehi, Province No.- 5, Nepal**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **as mentioned above** which shall be valid for 30 days beyond the validity period of the bid. If bidders wish to submit Bid Security in the form of cash, the cash should be deposited in:

If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. In the case of discrepancies or error in bid documents, bid notice or any other documents, **Gaidahawa Rural Municipality** reserves the right to amend and correct at any time.
8. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
9. Evaluation and Qualification Criteria:  
I. **Contracts of Similar Size and Nature:** Participation as Prime contractor, management contractor, or subcontractor, in at least 1 Contracts of building construction within the last ten (10) years, each with a value of at least NRs 1,00,00,000 (in Words : Ten Millions only ) that have been successfully or are substantially completed and that are similar to the proposed works.  
II. **Average Annual Construction Turnover:** Minimum average annual construction turnover of NRs 1,50,00,000 (In Words: Fifteen Millions Only) calculated as total certified payments received for construction contracts in progress or completed, within best three years out of last ten years. Only the net amount shall be calculated after deducting the amount for VAT and such amount shall be adjusted wholesale price index of Nepal Rastra Bank.

For Single Entity : Must meet requirement

For joint Venture : All combined partner Must meet requirements,

Each partner Must meet 25% of the requirement,

One partner must meet 40% of the requirements.
